Official Drawing Rules Minnesota State Lottery Winter Wins Online Giveaway January 23, 2025–February 27, 2025

- 1. To enter and be eligible to win, a player must:
 - A. be eighteen (18) years of age or older
 - B. have a registered account on and be logged in at <u>mnlottery.com</u> or on the Minnesota Lottery mobile app
 - C. have completed the entire address portion with their complete U.S. Postal Service mailing address, including zip code, in the sign-up area (used only for mailing any prize won)
 - D. have an account registration address within Minnesota or one of the four (4) states bordering Minnesota (North Dakota, South Dakota, Iowa, or Wisconsin)
 - E. Submit an entry in the Winter Wins Online Giveaway between 9:00:00 a.m. on January 23, 2025, and 11:59:59 p.m. on February 27, 2025 (any answer selected before submitting an entry has no bearing on the giveaway outcome)
- 2. Each player may enter only once.
- 3. Employees (including immediate family residing in the same household) of the Minnesota State Lottery (the "Lottery"), employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate and receive a prize from this Winter Wins Online Giveaway. If the prize is not claimed via email or is returned to the Lottery, the Lottery may declare the prize forfeited by the prizewinner, the prizewinner will have no further right to the prize, and the prize may be awarded to an alternate player. The Lottery is not responsible for delayed, lost, or misdirected electronic submissions made through the Internet.

5. The Lottery will conduct one (1) drawing.

The first five (5) prizewinners drawn will each receive \$50 worth of What-A-Hoot Lucky Lines scratch tickets, \$25 worth of Cozy Cash scratch tickets, one (1) Lottery-branded knit hat, one (1) Lottery-branded pair of mittens, one (1) Lottery-branded gray I'MN long-sleeve shirt, and one (1) Lottery-branded buffalo plaid knit scarf. The taxable prize value is estimated at \$0 (Lottery-branded merchandise and scratch tickets are valued at \$0).

One (1) prizewinner per household.

If any prizewinner resides outside of Minnesota, their scratch ticket prize will be converted to cash. The Lottery reserves the right to substitute prizes for any reason, including availability. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.
