

Official Drawing Rules
Minnesota State Lottery
Last Splash Scratch Online Giveaway
July 27, 2026 – September 6, 2026

1. To enter and be eligible to win, a player must:
 - A. be eighteen (18) years of age or older
 - B. have a registered account on and be logged in at mnlottery.com or on the Minnesota Lottery mobile app
 - C. have completed the entire address portion with their complete U.S. Postal Service mailing address, including zip code, in the sign-up area (used only for mailing any prize won)
 - D. have an account registration address within Minnesota or one (1) of the four (4) states bordering Minnesota (North Dakota, South Dakota, Iowa, or Wisconsin)
 - E. Submit an entry in the Last Splash Scratch Online Giveaway between 9:00:00 a.m. on July 27, 2026, and 11:59:59 p.m. on September 6, 2026 (any answer selected before submitting an entry has no bearing on the giveaway outcome)
2. Each player may enter only once.
3. Employees (including immediate family residing in the same household) of the Minnesota State Lottery (the “Lottery”), employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate and receive a prize from this Last Splash Scratch Online Giveaway. Prizewinners will be selected and eligibility determined by the Lottery. The decision is final, binding, and conclusive in all matters.
4. The prizewinners will be drawn at random from all eligible entries by a Lottery representative on or about September 8, 2026. The prizewinners will be notified via email; entrants are responsible for checking their email spam folders or adjusting their email settings to accommodate emails from the Lottery. The names and the cities of the prizewinners will be posted on mnlottery.com following prizewinner verification. If the prize is not claimed via email or is returned to the Lottery, the Lottery may declare the prize forfeited by the prizewinner, the prizewinner will have no further right to the prize, and the prize may be awarded to an alternate player. The Lottery is not responsible for delayed, lost, or misdirected electronic submissions made through the Internet.

5. The Lottery will conduct one (1) drawing. The first five (5) prizewinners drawn will each receive fifty dollars (\$50) in scratch tickets, one (1) Lottery-branded cooler bag, one (1) pair of Lottery-branded sunglasses, one (1) Lottery-branded beach towel, one (1) Lottery-branded can cooler and one (1) Lottery-branded t-shirt. The taxable prize value is estimated at \$0 (Lottery-branded merchandise and scratch tickets are valued at \$0).

One (1) prizewinner per household.

If any prizewinner resides outside of Minnesota, their scratch ticket prize will be converted to cash. The Lottery reserves the right to substitute prizes for any reason, including availability. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.

6. The Lottery, and/or any of their affiliated entities are not responsible, in any way, for any personal injuries, death, property damage, or other damages or expenses resulting from or arising out of any acceptance, fulfillment (including shipping and handling), installation, operation, loss, or misuse of the prize and/or any element thereof. All other costs and expenses related to acceptance and use of any element of the prize not specified herein as being provided may be the sole responsibility of prizewinner, including, without limitation, any fees, costs, and/or taxes related to the prize.

7. By entering this giveaway, prizewinners consent to full use of any and all information they provide on their account registration for publicity, public relations, and content creation purposes, including on Lottery social media channels and mnlottery.com, by the Lottery. Prizewinners may be required to execute a Winner Affidavit form and appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.

8. If a player has deleted their account, any entries submitted before the account was deleted will not be eligible for any prize.

9. Odds of winning will be determined by the total number of eligible entries received.

10. A prize won may not be assigned or transferred to another person. Federal, state, or local taxes on any prize are the sole responsibility of the prizewinner. All applicable federal, state, or local laws apply. Void where prohibited by law.

this giveaway, tampering, unauthorized intervention, fraud, technical failures, human error, or any other cause beyond the control of the Lottery that, in the sole judgement of the Lottery, could corrupt or affect the administration, security, fairness, integrity, or proper conduct of this giveaway, the Lottery reserves the right at its sole discretion, to cancel, terminate, modify, or suspend the giveaway.
